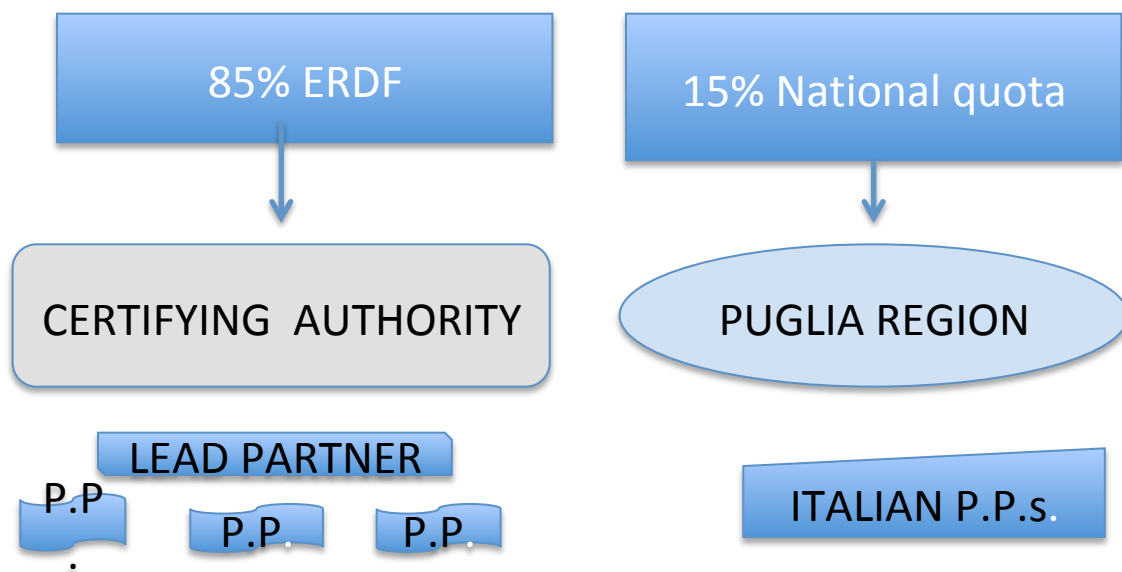

FINANCIAL FLOWS

The national co-financing (15% of the total project expenditure) is financed by the Rotation Fund (ex art. 5 of the Law. 183/1987) according to the CIPE Decision n. 10 of 28/01/2015.

Italian private partners cannot benefit from national co-financing (15%) and to finance their participation to projects' implementation use their own resources upon decision taken by Italy and the Programme.

HOW DOES IT WORK? (1)

If Italian Lead Partner

The LP will make the request for reimbursement for all the Italian public partners (Public Bodies and Public Law bodies) specifying for each of them the total amount of expenditure validated and admitted to reimbursement with the relative subdivision in EU and national quota

HOW DOES IT WORK? (2)

If Italian Lead Partner

2. Puglia region – Territorial cooperation Section - will provide the national quota amount to the Lead Partner, which will promptly transmit to the various Italian project partners the shares of their competence.

HOW DOES IT WORK? (3)

If Greek Lead Partner:

3. Each Italian project partner will make the request for its own national quota, specifying the total amount of expenditure validated with the corresponding subdivision in E.U. and national quota
